

TWO DAYS NATIONWIDE BANK STRIKE - A THUNDERING SUCCESS...

Comrades,

Greetings to all our comrades to have made the two days strike (31st Jan-01st Feb, 2020), a thundering success. We give herein, the events and talks that took place in the run-up to the strike, which reflects the insensitive attitude of IBA.

In another round of talks which took place on 13 01 2020, IBA Chairman narrated the general scenario in the banking sector and the constraints under which all of us were working, particularly in the Public Sector Banks. He pointed out that our demands for wage revision will have to be resolved keeping these constraints in mind to keep the competitive edge. He also stressed on the job security available in PSBs which cannot be overlooked while discussing the remuneration package. With this preface, IBA stated that it was difficult to improve their earlier offer and that the distribution will have to be within the overall quantum offered. IBA also explained their revised offer on PLI. Further, IBA offered encashment of 5 days PL every year in lieu of our demand for increasing the PL encashment at the time of retirement. IBA informed that they were not ready to accept our demand for 5 days banking.

On our not accepting their offer, after discussion, IBA offered as under:

Wage revision: 12.25 % with 2% loading

<u>Merger of Special Allowance :</u> not possible due to cost implications.

Revised PLI Offer:

	Increase in Operating Profit (Y to Y)	No. of days of PLI	As %
\succ	5 % to 10%	10 days	2.75
\succ	10 % to 15 %	14 days	3.84
\succ	15%	21 Days	5.75

In Banks, which will not register net profit but increase operating profit more than 5%, the PLI will be limited to 10 days/2.75 %.

Encashment of Leave during service: 5 days PL per year (in addition to encashment at the time of LFC). For employees with less than 5 years service: 7 days encashment per year.

Improvement in Family Pension: IBA is already seized of the issue.

Updation of pension : Cost needs to be worked out and thereafter the issue would be addressed.

In this background, the meeting of UFBU held at Mumbai on 13.01.2020 came to the unanimous and inescapable conclusion that intensified agitational actions have to be resorted to press our demands for reasonable resolution and satisfactory settlement.

In the meantime, in response to our Strike Notice, the Chief Labour Commissioner (Central), Ministry of Labour Ministry, Government of India called for a conciliation meeting in his office in Delhi on 27 01 2020.

During the discussion on 27.01.2020, IBA informed that they would be willing to call for further talks provided our strike on 31st January and 1st February is deferred. UFBU did not agree to this proposal and insisted that there should be adequate improvement in their offer before UFBU can consider any deferment of the strike. CLC advised that IBA should call the Unions for talks before the strike and try to resolve the issues.

In this background, IBA called UFBU for discussion on 30th January. The height of apathy was witnessed on 30th January 2020, when IBA made it clear that the hike in percentage from 12.25 to 13 and subsequently from 13 to 13.5.was valid for one day only. The same ' terms and conditions' was corroborated by the Chairman of IBA during another round of talks held later that day at SBI Corporate office, where it was increased to 15%, with a rider that other demands like 5 day week, the merger of special allowance, an increase of load factor were non-negotiable. Neither was there any clear cut commitment on the quantum of family pension revision, nor any idea on pension updation was offered. In fact, despite being reminded at every meeting, IBA till date has not provided any data on pension updation as sought by the Actuary engaged by AIBOC.

On 31st January and 1st February Strike days, the country witnessed an upsurge of bank employees and retirees who flooded the streets. Massive protest meetings were held across the country. We trust that the stupendous success of the strike, which gave a befitting reply to the centres of power and should be an eyeopener to the Government. We hope that the emotional outburst and protest of the bank employees and officers have been duly noticed by the IBA and the Government and given due cognizance of. The onus is now on the Ministry of Finance and the IBA to resume dialogue with an open and fair mind.

Comrades, the battle is not yet over. We will have to scale our agitations to the next level till we achieve our goals. While we thank our entire membership wholeheartedly for its excellent display of unity on 31st January, 2020 and 01st February, 2020, in sending strong signal to the Government / IBA, we appeal to the entire membership to be in readiness to implement further agitation programmes that would be decided by the UFBU in the days to come. Each one of us will have to wage a protracted battle to establish our legitimate demands. On the back of the success of the 2 days strike, we are embarking upon further challenges – next phases of strike action called by UFBU, namely, three days' strike from 11.03.2020 to 13.03.2020 and indefinite strike from 01.04.2020 onwards for a decisive battle.

These things became possible because of the encouragement, cooperation and support extended by you all and the indulgence shown by you all.

I convey my sincere thanks to the General Secretary, all my leaders, colleague functionaries of both past and present and my dear members for their guidance and support and affection shown towards me. I find the words inadequate to express my thanks to all of you except to say "I bow my head to each one of you and I salute you". Though I will be relinquishing my positions, I will be continuing as a soldier of the movement as it is my pleasure and passion.
