IBOA (TN & P) EXECUTIVE COMMITTEE MEETING HELD IN CHENNAI ON 03.09.2023

The IBOA (TN & P) convened its Executive Committee Meeting on September 3, 2023, in Chennai. The meeting was chaired by Com. S. Mohanraj, President.

During the proceedings, Com. S. P. Chandra Sekar presented the minutes of the previous Executive Committee Meeting, which received



unanimous approval from the members in attendance. Following this, President Com. S. Mohanraj proceeded to invite Com. R. Sekaran, General Secretary, to deliver the General Secretary's Report.

Com. R. Sekaran presented the General Secretary's report during the meeting, where the attendees observed a two-minute silence in memory of the comrades who passed away during this period. In his comprehensive report, Com. General Secretary covered various important topics, including the national scenario of the Chandrayaan 3 Mission, initiatives required to restore peace in Manipur, the decision to scrap the Pre-paid Smart Meters Project, discussions on fiscal federalism, and updates on the Delhi Ordinance.

Furthermore, he addressed matters related to the banking sector, highlighting developments in the commencement of the 9th Joint Note negotiation. In his report, he provided detailed insights into the promotion process, Performance Management System (PMS), the transfer process, enhancements in perks and perquisites, as well as updates on Central Consultative Meetings, FGMO Consultative Meetings, Zonal Consultative Meetings, work-life balance, Founding Day Celebration, vigilance issues, and the sale of Tanjore Land property. Additionally, he provided information about the purchase of land and building at Royapettah. The house extended its felicitations to Com. Tamil Thendral, who played a pivotal role in facilitating the sale of the Tanjore Land Property.

Following the report submission, the President proceeded to invite committee members for deliberations on the

General Secretary's Report. During this session, the Committee Members discussed the following key points.

• The BM and ABM review meetings conducted via video conference have been consistently extending beyond 9 pm. It is imperative for the Association to intervene and put a halt to this emerging trend.

• There is mounting pressure to promote third-party products, particularly Life Insurance policies from SBI, ABSLI, and Niva Puba. These insurance companies entice employees with incentive tours to various destinations. Zonal Managers (ZMs) and Deputy Zonal Managers (DZMs) are actively promoting these tour incentives, which contravene the guidelines set forth by the Finance Ministry. Customers are also being coerced into availing insurance products as a means to expedite the loan disbursal process.

- The reimbursement of fuel expenses for RACs should be strictly claim-based and should not be contingent upon the approval of the Zonal Manager.
- Zonal Administrations should refrain from implementing frequent transfers under the pretext of non-performance. Branch Managers (BMs) should be granted sufficient time to demonstrate their capabilities. In recent times, BMs have been compelled to allocate more of their time to video conferences (VCs) than to business promotion.





- Branch Managers are expected to provide immediate acknowledgments in WhatsApp groups. However, it is important to note that WhatsApp groups often disrupt the functioning of Branch Managers, as they are members of 13 to 17 different official WhatsApp groups.
- The absence of a Currency Chest in Dharmapuri, Tiruvannamalai, and Nagapatinam zones significantly hampers cash management services in the branches within those zones. Cash remittances are consuming a substantial amount of man-hours, and it is advisable to consider increasing the cash retention limit for feeder branches.
- It has been observed that the Zonal administration tends to accord more recognition and rewards for achieving targets in the Insurance business rather than the core business.
- Currency chests are not currently issuing sorted notes, which has implications for cash handling and processing.
- There is mounting pressure to implement IND OASIS even in rural branches.
- It is recommended to enable biometric authentication for Digi Jewel Loan accounts Currently, SR NOs are also not being captured in Digi Jewel Loans.
- There is considerable pressure for PMSBY and DEAF accounts.
- The bank organizes higher frequency of login days, which is creating challenges for field-level staff.
- It is recommended that pre-filled documents be made available for all loan accounts, similar to the provision offered for Home loans.
- The bank should consider procuring standard IT hardware, as a significant portion of the current hardware is of substandard quality.
- The payment of officiating allowance to eligible Branch Managers is a long-pending demand that warrants attention
- The bank should expedite the process of converting the Specialist cadre to the Generalist cadre.

- Zonal Offices should promptly clear TA/DA Bills within a few days instead of keeping them pending for extended periods.
- To ensure prompt delivery, it is advisable to consider delivering ATM cards through India Post rather than relying on courier services.
- The new Business Correspondent Channel Model is causing Business Correspondents to resign from their positions.
- The design of the circular search feature should be made more user-friendly.
- The bank should consider enabling the sanctioning of PMSVANIDHI Loans digitally, similar to the PAPL process.
- IT officers in Scale 1 and 2 should also be made eligible for mandatory leave.
- To enhance customer awareness and compliance, a pop-up message should be displayed when cash deposits exceeding Rs. 20 lakhs are made in an account.
- It is advisable to review the practice of including watermarked dates on documents issued with circulars, as this could potentially affect the legal enforceability of the documents if any additional document needs to be added after the date of documentation. Furthermore, capturing the date of documentation in CBS should be made mandatory.
- Consider discontinuing CCTV surveillance.
- The bank should withdraw the VORTEX machines, as they do not operate on holidays in all branches.
- It is recommended to reduce the rate of interest (ROI) on staff overdraft (OD) accounts.
- The role of DBC may be rotated among other officers. Traditionally, probationary officers underwent phase training across various desks However, they are now assigned the single role of DBC, which has resulted in demotivation among them.
- The bank should consider increasing the limits for staff benefits, including leased accommodation,



SHL, canteen subsidies, fuel reimbursements, entertainment allowances, and prepaid mobile charge reimbursements.

- To facilitate efficient clearing house operations, the number of holidays may need to be increased.
- A suitable location for a creche facility should be identified at the Corporate Office.
- Consideration should be given to raising the age limit and reimbursement amount for the creche facility.
- To ensure transparency in the promotion process, interview marks should be published
- Given that many of the parameters for administrative officers are non-measurable, the PMS score for these officers should accurately reflect their performance.
- It has been observed that MAPCs are primarily focusing on the fresh sanction of loans and are not attending to the renewal of loans.
- There is a need to digitize the KCC Gold Plus for enhanced efficiency and accessibility.

Com. R. Sekaran, the General Secretary, expressed his appreciation for the insightful deliberations and extended a warm welcome to the members' views. He expressed gratitude for the valuable suggestions provided on a range of issues affecting the Bank and the Officers. Com. Sekaran assured the House that the Association would diligently address these matters with the respective departments and Zonal Offices for resolution.

Furthermore, he provided an overview of the Association's efforts in addressing various issues concerning the officers and shared the current status of wage negotiations with the IBA (Indian Banks' Association). Com. Sekaran also requested the leaders to organize consultative committee meetings and member gatherings in all zones to gather input and suggestions on the challenges faced by the Bank and its Officers.

In an effort to enhance communication and obtain feedback from the field, he appealed to the House to update the association's WhatsApp groups. Com. Sekaran elaborated on the background of the discussed issues and outlined the steps taken by the Association, assuring the House that all matters brought up during the deliberations would be pursued for resolution.

Finally, the House unanimously adopted the report presented by the General Secretary.

The Treasurer, Com S P Chandra Sekar, submitted financial accounts, which were approved by the house.

Purchase of Land & Building at Royapettah and Sale of Tanjore Land Property

Dear Comrades,

We are pleased to inform you that significant developments have taken place regarding the property assets of our esteemed organization. As you are aware, the General Body Meeting of our IBOA (TN & Pondy) convened on August 28, 2022, in Chennai, approved the sale of our Tanjore Land property.

Our Association Office has been operating from premises on rental basis at No. 3, Sripuram 2nd Lane, Royapettah, Chennai 14. Our association had been actively seeking a property acquisition opportunity in Royapettah.

During this period, the owner of the premises conveyed their intention to sell the property, citing their relocation to their son's residence in Bangalore. Given the circumstance of our current premises being offered for sale, we promptly addressed this matter during our IBOA (TN & P) Executive Committee Meeting held in Chennai on February 11, 2023. After detailed deliberations in the meeting, the Executive Committee approved two significant actions. Firstly, they sanctioned the sale of our Tanjore land measuring 1387.50 sqft, with a transaction value of Rs. 63.80 lakhs, aimed at mobilizing funds. Secondly, the committee granted approval for the purchase of a land and building located at No. 3, Sripuram 2nd Lane, Royapettah. This property encompasses 1480 sqft of land and a constructed building with an area of 1258 soft on the Ground Floor and 1258 sqft on the First Floor, for a total sum of Rs. 3.17 crore, in addition to applicable registration charges.

Following these approvals, we are pleased to announce that the sale of the Tanjore Land Property was successfully completed and registered on August 19, 2023, for a total consideration of Rs. 63.80 lakhs. Subsequently, the registration process for the purchase of the Land and Building in Royapettah, Chennai, was concluded on August 30, 2023, for a total consideration of Rs. 3.17 crore with applicable registration charges.

With the acquisition of the Land & Building property in Royapettah, our Association has commenced operating from its own premises, effective from August 30, 2023. This marks a significant milestone in the 61-year journey of our Association, as it fulfills the longstanding aspiration of our past and present leaders to see our Association functioning from its own premises. We take pride in the fact that our Association now owns property in the heart of our beloved Bank's headquarters, conveniently located near our Corporate Office.

On this momentous occasion, we extend our heartfelt gratitude to the IBOA (TN&P) committee for their invaluable support and approval in both the sale and purchase of the referred properties. Their unwavering commitment deserves the highest appreciation and accolades.

We look forward to continued growth and success in our own premises, and we remain dedicated to serving the best interests of our members and the greater community of officers and for the common good of the workforce.

We profousely thank all concerned for their unfailing support and commitment to carry on our Association mission and vision.
